1. Applicant requests permission to use the following image/film/video(s) from the Oregon State University Special Collections (hereinafter OSU). List the image/film/video(s) individually with identification number:

2. Credit Line: "From the *Collection Name*, Special Collections, Oregon State University". This credit line must be included for use of each image reproduced.

3. Permissions are granted solely for non-exclusive, one-time use per medium. This means photomechanical, electronic, film, and other forms for the reproduction of an image in a specific work, presented in a single edition or medium published in one language, either for commercial or non-commercial (including academic) purposes. Subsequent uses, such as revised editions, paperback reprints, foreign-language translations, audiovisual adaptations, web-based applications, or electronic editions in CD-ROM or other formats, will require separate application to OSU for written permission, which may be granted in return for pre-payment of additional fees. OSU does not grant permission for exclusive use, and thus OSU can grant reproduction permission for particular items to be reproduced or broadcast in more than one place at the same time. New reproduction fees will be charged for photographic copies of OSU images previously obtained from the OSU Library for other purposes, or obtained from sources other than the OSU Library, or reproduced from OSU materials reproduced in previously published or broadcast works.

4. a) For use in printed materials, the publisher agrees to send Special Collections a copy of the publication containing the image listed. b) In the case of motion picture films, filmstrips and slideshows, the publisher agrees to send still photographs or photocopies of the title frame and the frame showing the picture credits. c) In the case of web sites or CDs, the publisher agrees to send images of the page(s) showing the picture and credit line.

5. Applicant agrees to not display, perform, modify, reproduce, or publish the above-identified image/film/video(s) or any other materials from the OSU Special Collections, except as expressly set forth in paragraph 2, above, or as otherwise expressly permitted in a written document signed by an authorized representative of OSU Special Collections (the Head of OSU Special Collections).

6. Special Collections does not claim to control all rights of reproduction for all materials in its collections. The publishing party assumes all responsibility for clearing reproduction rights and for significant infringement of the U.S. Copyright Code. Applicant acknowledges and agrees that OSU does not assume responsibility for copyright infringement or other violations of anyone's rights relating to Applicants obtaining a copy of or use of the photographs, regardless of whether OSU provides Applicant with a copy of the image/film/video(s). OSU makes no representation or warranty that it holds the copyrights or other rights of any other parties, Applicant hereby agrees to indemnify, defend, and hold harmless the State of Oregon, the Oregon State Board of Higher Education, Oregon State University, and their officers, employees, and agents from any such claims.

7. Special Collections charges a commercial reproduction rights fee of \$100 for use of an image in print formats. Special Collections charges a commercial reproduction rights fee of \$150 for use of an image in non-print formats.

8. Applicant agrees not to change any copyright notes or legends found on the materials obtained from OSU.

9. Applicant agrees to submit this form in duplicate, with each being in full effect as an original, if fully executed, along with the payment of the requisite fee to the Head of Special Collections. Permission is not granted unless and until a copy of this form is returned to Applicant bearing the signature of an authorized representative of OSU Special Collections.

10. Applicant acknowledges and understands that OSU is not required to grant permission to Applicant and that, in the absence of a signature by an authorized representative of Oregon State University Special Collections, below, that the permission is denied. OSU will refund the fee to Applicant in the event permission is denied.
